Statement of Faith

1. All scripture is God breathed. The words of the sixty-six books of the Bible were written by men of God and moved by the Holy Spirit. The whole Bible is without error in the original manuscripts and therefore authoritative in all matters of faith and practice. (2 Tim. 3:16, 2 Peter 1:20-21)
2. God exists eternally in three persons: the Father, the Son, and the Holy Spirit - and these three are the one God. (Deut. 6:4)

5. Salvation for man comes only by grace through faith in Jesus and His provision on the cross. The Holy Spirit indwells every believer at the time of conversion. (Eph. 2:5-9, 1 Cor. 12:13)
6. The primary purpose in the life of the believer is to glorify God in everything and to make Christ known to the unbelieving world. (Col. 3:23-24, 2 Cor. 5:18-20)
